1. BOOKINGS

1.1 All applications to register for the conference are subject to availability and you making full payment.

1.2 A confirmation of your payment will be emailed to you at the email address provided during your registration.

1.3 A Confirmation of your attendance will be sent to you by email within five working days of the event.

1.4 Delegate passes issued for use at the conference are valid for named attendees only and, subject to clause 3.3 below. You will be asked to provide a Confirmation of attendance during the conference. If you are unable to provide your confirmation of attendance which matches your delegate pass you may be refused entry to the conference.

2. PRICES AND PAYMENT

2.1 Our prices for exhibiting at the conference are set out on the relevant online Media Pack, which can be obtained from our event website. Prices may be subject to change year on year.

2.2 Invoice payments must be received by Iconic Media Solutions within 7 days of the invoice. For exhibition bookings made within 14 days of the event, payment will be required 3 days of the invoice issued, otherwise we cannot ensure all requested preparations for your exhibition stand or table will be made in time for the conference.

3. CHANGES TO THE CONFERENCE AND CANCELLATIONS

3.1 It may be necessary for reasons beyond our reasonable control to alter, the advertised content, date, time and/or location of the conference or the advertised speakers.
